## Report of the Provincial Delegate

Father Bonaventure Sauer, O.C.D.

Most of you have been conducting your community elections over the past couple of months. We friars, too, have elected a new provincial. His name is Fr. Luis Joaquin Castañeda. Originally from Mexico, he has lived in the States for a good while now and has family here. He obtained a licentiate in formation from the Salesianum in Rome. His work in the province has been mostly in the area of formation, although he has also served as superior of our house in Oklahoma City. Now we have asked him to serve us—and you—as our provincial superior.

Fr. Luis will take office at the start of our Provincial Chapter, which opens on Monday, May 30. It used to be that the friars elected the provincial at the Chapter itself. But for the past 15 years or so—I can't remember exactly—we have elected the provincial prior to the chapter by means of a general election in which all the friars of the province participate. This way of electing the provincial is increasingly the norm throughout the Order, I believe.

When it was still our practice to elect the provincial at the Chapter itself and only by those friars who attended the Chapter—not all friars of the province did—our *Constitutions* required that all friars of the province be consulted in some manner prior to this formal election of the provincial at the Chapter itself. Thus, in our province we would conduct a kind of nominating ballot, in which all the friars took part, to determine which candidates the friars who attended the Chapter would be able to pick from in electing the provincial. It was in this process of nominating candidates for provincial that we used to use a ballot similar to the one you use for the election of local councilors. One could write down three names, ranking them 1, 2, 3, and assigning them three points, two points, and one point accordingly. As a nominating process this way of casting one's vote had certain advantages. In the course of an actual election, though, it is questionable whether it serves any purpose, while being perhaps unduly complicated.

It is my suspicion that the way in which you vote for councilors—using a ballot on which you rank your three choices—is derived from our old way of nominating candidates for provincial. But now that you've had some experience electing councilors in this way, we might ask whether you find it a good procedure. Is it a helpful and serviceable way of conducting the election? When casting your vote, do you find being able to write three names and rank them accordingly a good way to express your wishes for whom you'd like to see on the council? Or is the procedure overly confusing and not particularly helpful? Is this manner of ranking your choices beside the point, giving results which are not really representative of the base of support a candidate might have in the community? Is there, in other words, a better, simpler, and more accurate way of conducting your election of councilors?

I would invite any of you who have thoughts or ideas in response to these questions to please send them along to me. I would be most interested in hearing from you.

#### Central Office/Provincial Secretary

I didn't receive the number of responses I expected to my proposal in the last *Flos Carmeli* about establishing an OCDS central office and secretary in the province. I am appreciative of those who did take the time to write. Thank you. As a rule the responses I did receive were positive. You saw the need for such a position and felt that, generally speaking, it would be affordable.

Of course, the increase in dues was a concern to some, as is to be expected. I am quite sensitive to this concern. Please be assured of that. And let me make another point. This proposal—the idea of setting up an OCDS central office run by a provincial secretary—is not something I just dreamed up. Nor is it something I would ever try to impose on you. It comes from the perceived needs of the Secular Order in the province and is a way of trying to address those needs. Think of it as putting in place a kind of "staff" for the Secular Order of the province. As with a parish or chancery office, we need someone to help run things on a regular, day-to-day basis, so to speak.

Where does the proposal go from here? Between now and the upcoming Provincial Chapter at the end of May, I will prepare a formal statement of the proposal which will include a detailed job description and some mechanism for financing the position. I will then present this proposal to the friars at our Provincial Chapter, giving them a chance to suggest changes and improvements before seeking their formal approval. We will also discuss it when the OCDS Provincial Council meets with the friars at the Chapter. This meeting will be either on June 6 or June 7—the date isn't finalized yet. The friars will discuss other matters with the Provincial Council on that day, of course, not just this proposal, as together the province plans for a new triennium.

You will probably be hearing more about the proposal in the next issue of the *Flos Carmeli*. In fact, we might even publish the job description along with the proposal for how to finance it. You would then have an opportunity to offer further comments and criticisms. And I'll try to come up with some way to seek the general approval and permission of all the Secular Order communities in the province before proceeding further. We would then be looking at, say, September at the earliest as a start-up date for the position, provided things goes forward at all. About that we shall see.

#### A Word about Dues

I have never been particularly happy with the use of the word *dues* to describe what you are doing in helping to support your community and the province financially. The word *dues*, to my mind, conjures up images of a country club or of some private organization to which one is required to pay a membership fee in order to belong. But that, of course, is not what you are doing. There is not—or at least there shouldn't be—a membership fee to belong to the Secular Order. Rather, each local community, as well as the province as a whole, and the Order itself with its general office in Rome, has its operating expenses. These expenses have to be met somehow. So, like any family or ecclesial community, we pool our resources.

Of course, there is more than one way to do that—for a community to pool its resources and meet its expenses—but at present the way it is done among yourselves is for the local community to decide upon an appropriate assessment or fair share for each member. The local council, with the help of the treasurer, calculates the community's upcoming expenses over some timeframe. Three years is a good block of time for planning's sake. These expenses will include things like stipends, facility use fees, costs incurred in the apostolate, charitable donations, etc. They will also include the assessment the province itself places on each local community in order that the province might meet its own expenses—which, for its part, includes the assessment the general office in Rome places upon the province.

So, then, the local council prepares a kind of budget and calculates the community's projected expenses. Then it asks the community to decide what each member will need to chip in for it to meet its expenses. According to your *Provincial Statutes* [see *XVIII* (1)], it is up to the community itself to (Continued on page 6)

determine this amount. The budget prepared by the council is thus a basis for the community to deliberate over and decide this question. Although it would be wise for the council to work up a three year budget to assist the community in its deliberations, it might also be a good practice for the community to return to this question every so often—probably yearly—to review what its projected expenses are and see if the assessment (or dues) it has decided on appear to be sufficient to meet those needs or are perhaps too little or maybe even too much.

Indeed, there may be years when the community's expenses turn out to be less than what was projected. In such circumstances the community might lower or waive some portion of the amount being asked for from each member. Or the opposite might happen, and some unexpected expense pop up, requiring the community to consider raising the amount asked for, at least in the short term. I do think that all of you understand these matters, no doubt better than I do.

Statute XVIII (1) goes on to state: "A member's inability to pay dues, temporarily or indefinitely, is a matter to be handled by the Local Council with discretion and sensitivity. If necessary, more affluent members are encouraged to contribute more to make up any loss of income"—something they are usually glad to do. Of course, as all of you understand, no one should try to take advantage of this generosity. Indeed, a willingness to assume responsibility for helping to support one's community financially is an essential part of the vocation. Yet a Secular's ability to meet that responsibility will vary from person to person and across different times and circumstances in life.

If you look at the province's financial report prepared by Pat Darby—which is published in this issue of the *Flos Carmeli*—you will see that the provincial account is nicely in the black. We will most likely have some added expenses during this present calendar year since our province is hosting the Regional Congress in Lafayette this summer. Thus, it's good to have the extra on hand. (Oh, and there's the provincial delegate's upcoming sabbatical at the University of Hawaii to keep in mind.) At the same time, if at the end of this year we continue to have such a surplus in the account, then the province might actually be able to waive part of the assessment it asks of each community next year. If we do try to set up a central office, though, along with a provincial secretary, then this surplus in the account might come in handy for covering start up costs without having to ask anything additional from the communities at this time.

## PC requests feedback on Dismissal Statute

In the past few Provincial Council reports, we have mentioned our work on a new statute regarding how to dismiss members from the Order. The Constitutions grant the Local Council the ability to do this however, they do not outline the proper procedure. In order to dismiss someone from the Order, it is important that certain aspects of Canon Law be followed in the process. The process must be fair and give the individual the right to appeal.

Currently the draft of our dismissal statute is with a canon lawyer for review to affirm that we have developed a procedure that meets that standard. While we await feedback from the canon lawyer, we thought we'd make the **draft** statute available for feedback.

#### **Draft**

The Council may dismiss a member under the grounds provided in Canon 316 (nn.1-2) of the *Code of Canon Law* or under any of the following grounds considered as "just cause" in accordance with Canon 308:

chronic absenteeism (Provincial Statutes XVI.5);

willful violation of the Constitutions and/or Provincial Statutes;

grave abuse of authority;

actions that seek to divide the community or damage the reputation of another;

serious and repeated disruption at community meetings;

violent or threatening actions towards another;

serious violations of the Promise, and in particular of the evangelical counsels of chastity and obedience as they are set forth in the Constitutions, nn.13 and 15.

Before considering dismissal the Local Council shall first address the problem with the member in at least two private meetings. The matter should be handled with charity and pru-

dence. At the first meeting a letter should be given to the member detailing the problem, any steps the Council would like to see the member take in addressing it, and how the council might be able to help the person in doing so. A signed copy of this letter should be placed in the member's file. The Council may suggest that the member take a leave-of-absence for some agreed upon period of time if that would seem helpful to the member and/or to the community. There should be a follow-up meeting to this first meeting.

If the member fails to take the steps asked for within six months of the first meeting, and if the problem persists unchanged, then the Local Council shall again meet with the member and inform him or her that dismissal is being considered. The member shall be given a letter to this effect, a signed copy of which shall be kept in the member's file. The Council may again request the member take a leave-of-absence. If the member refuses, the Council may remove the member's active and/or passive voice. (Removing passive voice means that the member cannot hold any office or assume any other responsibility in the community. Removing active voice means that the member cannot vote in any community election or in deciding business or other community matters.)

**Formal Consultation of the Provincial** (see *Constitutions* n.47e). If the member has not addressed the problem as asked within the next six months, the Local Council shall consult the Provincial (or his Delegate) regarding the possible dismissal of the member from the Order. The Provincial (or his Delegate) should review the process followed by the Local Council. Once he is assured that the Local Council has acted properly in following the above process and that the problem is indeed sufficiently grave to warrant dismissal, he shall inform the Local Council, and the Local Council may proceed with the dismissal. Notice of the dismissal must be given to the member in writing, with a signed copy placed in the member's file. The Local Council may request the presence of the Spiritual Assistant as an observer when they meet with the person about the dismissal. Upon dismissal, the person is released from the Promise and is freed of the obligations assumed as a member of the Order. Barring reversal on appeal, dismissal from the Order is final. The person is not permitted to re-enter the Order at a later date.

**Appeal Process**. The member has a right to appeal this decision. In the letter of dismissal the Local Council shall notify the dismissed member of this right and explain how he or she may proceed with an appeal.

The dismissed member should first appeal in writing to the Provincial (or his Dele-(Continued on page 11)

gate). This appeal must be made within 90 days of receiving the dismissal letter. The Provincial (or his Delegate) shall respond to the appeal within 90 days of receiving it. He should meet with both the dismissed member and the Local Council to review the situation. He may consult with the Spiritual Assistant. He may also seek the advice of the OCDS Provincial Council.

He will then respond in writing to the dismissed member either supporting the Council's decision or reversing it. Or he may suggest another option to follow, should one present itself. Copies of the appeal and the response will be placed in the member's file.

After the Provincial (or his Delegate) has responded, and if the dismissal has been upheld, the dismissed member may appeal in writing to the OCDS General Delegate. The dismissed member shall be informed of this right by the Provincial (or his Delegate).

At any point in the process, the member, the Local Council, the Provincial (or his Delegate) may consult the OCDS Provincial Council for their advice. Since the Provincial Council has no juridical personality, it may only offer advice. It may not render a binding decision.

All involved shall maintain confidentiality throughout so as not to damage the good name and reputation of any other.

## **Letter from the Definitory**

+ Rome, March 7, 2011, Memory of Saints Perpetua and Felicity

Dearly beloved brothers and sisters in Carmel:

PEACE.

From March 1<sup>st</sup> to the 6<sup>th</sup>, we met in Rome to hold our eighth meeting as a Definitory. On 5<sup>th</sup> March, some of us had the pleasure of being able to assist at the Ordination to the Deaconate in the basilica of San Pancrazio of eleven of our students from the International College of Saint John of the Cross by His Excellency, Cardinal F. Arinze. As a most joyful and unforgettable corollary to our meeting, Mons. João Braz de Aviz, recently appointed by Pope Benedict XVI as Archbishop Prefect of the CICLSAL, visited our General House today to have a meeting with Fr General and the Definitory, and afterwards to join with us in Evening Prayer and supper.

Concerning the topics discussed during these days, we first of all evaluated the more recent regional meetings at which Fr General presided, keeping in mind that in many places meetings were also able to be held with our Discalced Carmelite Sisters.

During this meeting we also discussed at length the situation of our Discalced Carmelite Friars in the Church of San Miguel de Sucumbios. As you already know from our last letter, the Congregation for the Evangelization of the Peoples had decided to withdraw the *Ius Commissionis* from the Order and give it to the *Virgo Flos Carmeli* Society, the "Heralds of the Gospel", and appointed the Most Rev. Fr Rafael Ibarguren, EP, as Apostolic Administrator.

Since Fr General was unable to go himself to Sucumbios, he sent Fr Emilio J. Martínez, his Vicar, on a fraternal visit, for the purpose of evaluating the situation of our friars there and resolving, as far as possible, difficulties that have arisen.

After visiting in Bogotá Fr Jorge Mario Naranjo, the Provincial of Colombia and Superior of the missionaries, he set out for Quito where he was able to meet Mons. Gonzalo López; and from there he travelled to Sucumbíos, accompanied by Fr Carmelo Hernández, Delegate of Ecuador, and Fr Pedro Tomás Navajas, the Provincial of Burgos and former superior of the missionaries.

A positive fruit of the visit was being able to establish channels of communication and to be able to talk with our Discalced Carmelite Friars living in the Vicariate of San Miguel de Sucumbios (ISAMIS), under the new administration; he was also able to get to know the other religious and lay missionaries who work with them. They were able to have an interview with the new Administrator, in the hope of establishing channels of dialogue guaranteeing the presence of the Order in this area. It is the desire of this Definitory to keep these channels of communication open and to help solve any difficulties that may arise; we hope we can do so by open dialogue with the Congregation for the Evangelization of the Peoples, the Most Rev. Rafael Ibarguren, EP, the Apostolic Administrator, and naturally, with our Discalced Carmelite missionary brothers and their Superiors.

With regards to the Delegation of Israel, we continued working in this Definitory to strengthen our presence there. It was a pleasure to receive the willing acceptance of some religious to go to the Holy Land to take up posts in the Stella Maris and Muhraqa monasteries. Thus, in the coming months, Frs Milton Moulthon, Gustavo Prats, Saverio Gavotto and Arnold Boehme will join the Delegation. We are pleased that these friars and their Superiors have been

willing to accept these transfers so as to serve the Order in a place of such importance to the Discalced Carmel.

What remained to be discussed about the Delegation of Israel, were the Carmelite formation courses; they are already prepared and will be held on Mount Carmel (Stella Maris). The Spanish-speaking group will begin, and in the coming weeks the different Provinces will be reminded of the content and conditions of enrolment for these courses prepared by Fr Augustine Mulloor and the Secretary for Formation, Fr Johnson Perumittath.

In the last *Letter* we informed you that we carried out a survey within some Italian Provinces, with the idea of beginning a process of restructuring and unification. On seeing the results of the survey, the Definitory decided, according to the provisions of n° 147 of the Constitutions and n° 156 of the Norms, to take over the government of the territories of the Roman and Tuscan Provinces for a triennium, constituting them as a circumscription "ad instar Commissariatus" with the view of erecting a new "Province of Central Italy". They appointed Fr Gabriele Morra as the Commissar.

Both Provinces will celebrate their Chapters in April and May, 2011, in the presence of the new Fr Commissar and the Definitor in charge of the area, Fr Emilio J. Martínez. In their Chapters, each one will elect a Delegate and two Councillors who, together with the Commissar, will make up the Council of the new area of jurisdiction.

Over and above the doubts and fears that such a decision could generate – new in the recent history of the Order – we trust we have interpreted the Lord's will in bringing it about. It is a process we begin in hope, since we trust in the help of the Holy Spirit to pour out his fruits of love, happiness and peace on us and our brothers as together we undertake what we hope will be a good success. To the illustrious past of these Province is added the present courage to begin this process and the hope of a future founded on the desire to go forth, faithful to what Our Holy Mother Teresa said: "Now is the time to journey forth".

These journeys towards union and restructuring seem to be a sign of our times, especially in those geographical areas most troubled by the lack of vocations and the ageing of our friars and nuns. Thus, in the meeting of the Provincials and the Councils of the Iberian Peninsula with Fr General and the Definitor entrusted with this area, the unanimous decision was taken to begin a process throughout the coming triennium, weighing up the possibility of one sole Province for the whole Iberian Peninsula, analysing carefully all the advantages and the disadvantages.

In the same way, our Discalced Carmelite Nuns in Spain have decided to begin a similar process, coordinated by all the Federations, which will allow them to draw up a map of foundations that are reasonably sustainable, being attentive in the process to the evangelical and teresian criteria that the communities themselves will be establishing.

After analysing the financial situation of the Centre of the Order for 2010, we passed on to study other questions relating to the Provinces questions concerning monasteries of the Order which needed our attention.

We approved some decisions of recently celebrated Chapters or Chapter Congresses and discussed the petitions from the Provinces or Commissariats of Malabar, Andhra Pradesh and Madagascar. Andhra Pradesh will transfer the house for philosophy students to Pendurthy because of the increasing number of vocations. Madagascar will establish a parish in the Diocese of Morondava, where one of our friars, Mgr. Fabien

Raharilamboniaina is Bishop. We also studied a letter from the Delegation of Egypt, as well as the collaboration agreements recently signed by the Manjummel Province with the Roman Province and the Vicariate of Australia.

Concerning the Teresian Centenary, Fr Emilio J. Martínez informed us of the latest developing initiatives, about which you will be informed, especially through the Web page <a href="www.paravosnaci.com">www.paravosnaci.com</a>. We are anticipating here some cultural initiatives of the Order which, in this sexennium, will form part of the Centenary. With the help of the Definitors in charge and the Conferences of Provincials involved, we would like to plan three congresses: one in the Czech Republic for central and eastern Europe, another in India for Asia and one more in Africa. The various American CICLAS are already preparing to involve the whole S. American continent, for which this Definitory offers their collaboration.

We returned to the subject of formation, this time discussing initial and ongoing formation, in charge of Fr Augustine Mulloor. Briefly, the courses of formation for formators and community animators will begin in the Asian and African zones. There are 26 religious enrolled: 16 from India, 3 from the Philippines, 2 from Indonesia, 2 from Tanzania, one from Cameroon, one from Nigeria and one other from Malawi.

Our Order has already studied on various occasions the way of inserting our charism and activities into the "New evangelization" plan. The recent creation of a Vatican Dicastery for this important matter, invites us to reflect anew on this important initiative. In the light of this, Fr Albert Wach presented a first draft to be studied by the Definitory, so that we can share and complete the result of our work with you, our brothers and sisters.

Fr George Tambala presented "Congress for Africa" to be celebrated from 6<sup>th</sup> to 10<sup>th</sup> February next year in Nairobi. This Congress will reflect on the Carmelite identity and mission in Africa, trying also to take helpful decisions dealing with the changes that time has brought about for our missionary work there. It will seek ways of preserving and sharing with the African people what is specific to Carmel. It is also necessary to develop channels through which African Carmel can have a greater voice and autonomy. The different circumscriptions are already studying work documents prepared for this purpose.

In dialogue with our Secretary for the Missions, Fr Julio Almansa, the Definitory discussed the concept of mission, which has changed, and not only in Africa. Before, when speaking of the missions, what was understood was going to foreign countries, to distant lands, to men and women of other countries to preach the Gospel to them.

Inspired by the words of Fr Jesús Angel Barreda, OP, we understand that this situation has now changed, because the frontier is not so much a geographical limit, but it means going out from, abandoning a situation – generally agreeable and tranquil – to open ourselves to new possibilities that are not so secure, but which could offer us the possibility of change and growth. The frontier then becomes a symbol to define new social and human spaces and horizons more than having a geographical connotation.

#### **Definitory letter cont.**

If the concept of mission has changed, it does not mean that mission has disappeared. In the same way that the *classical* missionaries left their world, their security, all they knew, to cross frontiers that took them far from what was their homeland where they had to face previously unknown difficulties and risk-filled situations, missionaries today are not infrequently required to cross new frontiers, without leaving where they are.

Meeting our brothers and sisters in these visits allowed us to come in contact with Discalced friars and nuns disposed to leave everything. There we are not moving in the field of words; we are in direct contact with brothers and sisters who are disposed to *risk their lives*, if they have not already done so.

There are very many of our brothers and sisters who, without thinking of themselves but of the Order and the Church, are willing on the word of their Superiors to leave everything, to change place, to leave aside all their securities and often their trusted certainties, in order to respond to the new needs of a changed world.

For example, the journey undertaken by the Discalced Carmelite Nuns in Spain, to begin a process of restructuring their foundations; like Jesus, like Teresa, they are not seeking to remain in security, but to take risks and start walking, like pilgrims.

They are also seeking help from their brothers so that these processes are not hindered, and so as not to arrive at the same old solutions; from what we have seen and tried, this only make matters worse and, at times, create situations of great anguish, situations that are next to impossible to resolve.

We have also witnessed the capacity to take risks that are imbued with trust, in our brothers of the Roman and Tuscan Provinces, in the Iberian Peninsula, in our brothers in India who are coming to the help of many of Carmel's presences in Europe, in those friars who have accepted our proposal to strengthen our presences in the Holy Land, etc.

It is normal to have fear in crossing this frontier, aware that this requires us to leave aside what is secure and to be open to the unknown. But we must trust in the strength of the Spirit, the Comforter.

For our part, as a Definitory, we cannot remain impassive, faced with the calls for help we receive from our brothers and sisters who are living in difficult situations, precisely because they feel anchored down by structures that hinder them living their lives as Discalced friars and nuns with dignity. We ask you for your prayers and help at this time to be faithful to this endeavour. With fond regards, your brothers:

#### 1. Georgetown, TX—submitted by Lydia Pena


