- Do you have suggestions to improve our present Formation Program to empower each of our members to live more fully their lay Carmelite identity and vocation and contribute more to the evangelization in the family, at work and in the social world?
- Give examples of the more significant and specifically apostolic works that are being done individually or communally in your community.
- How does your community make the OCDS known and promote vocations?
- What do you think about setting up an OCDS International Council as a consultative body? How should it be organized?
- What message would you have for the friars who will be attending the upcoming General Chapter in the light of the challenges of today's world and the urgent need for evangelization ("signs of the times") as evidenced in the United States?

Please give thoughtful consideration and reflection to these questions. Pray about them. Share with your communities from your experience and feelings. Your presidents will forward your information to me, and the Provincial Council Members and I will put all in a good form to be sent to Father Debastiani. This is a wonderful opportunity for you to contribute to the future of our Carmelite Secular Family, and to make a meaningful difference.

This event is sponsored by the Oklahoma OCDS Provincial Council in conjunction with the Houston OCDS communities. OCDS Atlanta Congress 2014

Our 2014 Congress in Atlanta, August 21-24, was an intimate affair by many standards. The numbers were not as high as we'd hoped, but the Teresian spirit and virtues were in evidence everywhere. The oppor-

tunity for meeting and getting to know each other from around the country expands our identification with our Order and vocational family. Father Luis Joaquin Castaneda, O.C.D. Provincial for our Oklahoma Province of St. Therese, warmly welcomed participants, especially thanking those whose prayers and hard work produced the Congress. A highlight for many was the up close and personal encounter with our new General Delegate, Fr. Alzinir Debastiani, OCD, from Rome.

I think most would agree that Father Alzinir personifies those Teresian virtues of humility, detachment and charity in which our Lord is forming us in Carmel. He opened his Conference Friday morning with a quote from Pope Francis: "Humanity will be worse for every selfish choice we make." We were directed to "choose deep down to be for others, with others", to recognize that, in Carmel, "I am a mission on this earth." Fr. Alzinir, whose native language is Portuguese, did his best to communicate with us through the language barrier. With the help of the California friars who hosted him prior to the Congress, practicing his English pronunciation and translating his Conference, and of our own Fr. Bonaventure who served as master of ceremonies as well as reading the body of Fr. Alzinir's presentation, we were well-instructed about the implications of our new additions to the OCDS Constitutions: on community responsibilities and the exalted role of St. Joseph in our Order.

Our General Delegate assigned homework for all of us: Father Alzinir Debastiani, OCD,

Study the new additions to our Constitutions, personally and in our communities: III - B on Fraternal Communion, and 31 - A, on the role of St. Joseph in the Teresian Carmel.

And make the changes that are needed to live them out.

It is always a pleasure to witness the humility of our OCD friars, who seem to find their own pleasure in the company of their Secular brothers and sisters. At a Congress, we also get to witness the easy camaraderie among the friars themselves, with its little glimpses into private jokes! This was particularly evident in Father Bonaventure's introductions of speakers. Our first Conference, by Fr. Stephen Sanchez, was on Teresa's epistolary - letters of spiritual direction - which revealed her strong distaste for letter-writing when she had so many spiritual and administrative duties to attend to. Fr. Stephen pointed out that, as with most of us, Teresa "continually grew into her integrated discipleship." He asked us, "How often do we allow our preferences to dictate our discipleship?" We were encouraged to mine our holy mother's letters for the virtues we are called to emulate, magnanimity in service being one, as demonstrated in the quality of her spiritual direction and love expressed in her letters, as well as her diligence in writing them.

Each of the Workshops offered good formation for growing in our capacity for community life. "I see out ... but I cannot see myself," Betty Turicchi pointed out to those attending her workshop on Conflict Resolution. We need one another to see ourselves, to know ourselves. Lack of insight, she explained, is a problem in

interpersonal relationships, and sometimes especially for those with delegated authority.

Proper motivation in accepting roles of leadership does not often come with the skill to practice delegated authority. For instance, we must learn the tools for direct communication rather than indirect communication, if we are to become transparent in our relationships in community. Jesus demonstrated direct communication as he addressed conflicts; we need to follow his example here as in all things.

Dr. Keith Egan, in his keynote address, reflected on the reality that "The quality of one's life depends on the quality of one's relationships." St. Teresa's direct way with our Lord was consistent; her many terms of endearment manifest a dynamic, loving, confident friendship with Him whose love she knew intimately. "I don't know what they fear, who fear to begin the adventure of mental prayer, the prayer of recollection," Dr. Egan quoted. We are blessed to be con- versation partners with Teresa through her writings, and we are blessed to be in contemplative conversation with our Lord through lectio divina, mental prayer, the Sacraments, study of His Word.


Fr. John Michael Payne, OCD, shared interesting information about many lesser known Carmelites, including Bl. Baptist Spagnoli, Bl Teresa Mary Manetti, OCDS, Bl Alphonsus Mary Mazurek, OCD, St. Joachina Vedruna de Mas, OCDS, Bl Maria Sagrario, OCD, and Bl Josepha Naval Girbes, OCDS. He also

mentioned that we lost 25 friars in the Spanish War of 1936, five of whom served in the Oklahoma Province at one time.

I think many were surprised by the vulnerability revealed by Fr. Bonaventure Sauer, our own Provincial Delegate, as he deepened our appreciation for St. Teresa's poetand even shared some of his own. "The experience of God eludes and escapes our language barriers," Father asserted, at times some are given to articulate it with a certain spirituintuition, as our holy mother was. His Sunday morning Conference left us with a happy anticipation of exploring Teresa's poetry with a more open mind and heart, perhaps daring to free our own poetic intuition.

The entertainment provided by John Michael Talbot Saturday night showcased the gifts of his guitar and his voice, grown more sonorous than ever.

I have to applaud the energetic, unobtrusive multitasking talents of James Louviere, of Champions of the Truth, for singlehandedly recording the talks and workshops at our Congress, and providing most of them soon after they were given! I remember he had a team working with him in Lafayette, in 2011, but this time he managed an impressive feat "alone with the help of God".

Report of Plenary Council meeting at Atlanta Congress

OCDS PROVINCIAL CONGRESS IN ATLANTA

FRIDAY, AUGUST 22, 2014

The meeting of the Provincial Plenary Council was opened with prayer by President, Mary Kay Daniels. The members of the new Provincial Council and the Provincial Delegate were introduced to the assembled presidents and delegates, and the proposed agenda was presented, to consist of three topics:

Reports

Previously submitted questions and answers Father Provincial's requests for collaboration

Reports

- President Mary Kay Daniels, Sioux City, Iowa, announced that there will be a workshop for Community and Study Group Presidents, Formation Directors, and new Council members on March 13, 2015, in conjunction with the Provincial celebration of the 500th anniversary of the birth of our holy mother, Saint Teresa of Avila. She then introduced Councilor Chris Wood of Houston, TX.
- 2. Chris Wood gave a description of the Centenary Celebration. This event will take place in Houston, and will begin with the Workshop, with participants gathering for Evening Prayer and a meal Thursday evening, March 12, 2015, at the Houston Omni Hotel. The workshop itself with take place Friday, March 13. The anniversary event for the general membership of the OCDS will begin Friday with an evening meal appropriate for a Friday of Lent and a conference on St. Teresa by Father Bonaventure, our Provincial Delegate. On Saturday, the events will be open to the general public, and will consist of Liturgy of the Hours, a procession and a special mass at St. Cyril's Church (bus transportation will be provided free of charge for those staying at the Omni). Religious from all branches of the Carmelite Family present in the Houston area will be participating in the liturgical celebrations. There will be special music. O.Carm. will sponsor a reception in the Church Hall after the mass, and there will be a conference by Dan Burke, representing the Avila Institute, again for a general audience. OCDS members will continue their celebration with a program at the hotel Saturday afternoon and a banquet. There will be additional programs on Sunday morning, with the event ending at noon. The registration for the event is \$125, and the hotel rooms are priced at \$99 (occupancy up to 4 people per room), but at the present time, there are a limited number of rooms available, so we are asked to sign up soon! Note that the only cost for the workshop is the additional hotel night.
- Kathy DeWine, Knoxville, Tennessee, reported on the past Triennium. We are the smallest of the three Provinces. In 2011 there were 23 canonically-established Communities, 15 Study Groups, and 1 Group in Discernment. In 2013, there were 24 Communities, 12 Study Groups, and one Group in Discernment. There are approximately 850 total members, but this number is decreasing as we age.

Barbara Tinervia, in the Central Office position, has made a tremendous difference in the functionability of the Province. Two Provincial Councilors have had to resign, one for professional reasons and one for health reasons.

There was no Province-wide election due to lack of nominees, therefore the Provincial Delegate appointed the new Councilors. The term of office has been reduced from 6 years to 3 years. Travel costs for Visitations will continue to be subsidized by the Provincial Treasury.

Father Bonaventure then came to the podium to underline the need to attract young members through vocation awareness.

4. Jo Ann Murphy, Austin, Texas (formerly of Washington, DC in the Eastern Province), announced that she will be assisting Father Bonaventure with the Flos Carmeli (only 22% of recipients are reading the pdf version). We are to continue sending Community news items to Father Bonaventure, but general articles and articles of a spiritual nature should be sent to Jo Ann at <u>jmurphy12513@gmail.com</u>. Provincial Council communications that require action on the part of local communities will go to the Presidents for distribution via email. Any deadline will appear in the subject line.

5. Claire Bloodgood, Georgetown, Texas, reported on the survey of Community and Group Apostolates. We are reminded that the purpose of the community or group apostolate is to spread Carmelite spirituality. She cited communities which sponsor speakers, sell books, provide Carmelite literature to seminarians, give classes to priests (in a large city), hold schools of prayer, teach *lectio divina*, and give teachings on Carmelite saints.

Questions and Answers (submitted by attendees in advance to the PC):

Q/A: Concerning indigent members (persons without any transportation and/or financial resources): If the person is Professed and there is a sudden loss of assets, we need to act out of fraternal charity. If the person comes to us with a genuine call to Carmel, God will provide what is necessary, but the Council must look at the long view: Is the call to some other contemplative life: can the person's spiritual needs be met in private prayer or in a prayer group other than Carmel? The local council must try to discern what is best.

Q/A: Can more talks on Carmelite spirituality from retreats and Congresses be made available online? Jo Ann Murphy pointed out that there are numerous copyright issues involved! For example, the company which records the conferences at our Congresses owns those copyrights, and Friars must give permission before their Retreat talks can be posted online. We are reminded that there are two websites in our province, one for the Friars (carmelitesok.org), and one for the Seculars (thereseocds.org), and that there are a lot of resources published on those two sites. It might be possible for Mount Carmel Center (where Fr. Bonaventure is now resident) to podcast some of their presentations.

Q/A: A case study concerning a person who was clothed but moved twice before making any Promises, and asked twice for medical excuses; then finally asked for Isolate status from a different Province. Since she was never professed, she was never a member, and therefore can't be an Isolate. The policy is that if one has made the First Promise, one may be released and then return ONE time, but not twice. If a Professed member has medical problems, one is placed on Infirm status, not Isolate.

Father Luis asks us to consider three areas of collaboration:

1. Revision of Statutes and Formation Guidelines at the 10-year mark, as required by our Constitution.

2. What is the solution to the lack of nominations and thus the failure to hold Provincial Council elections this year?

3. How can we help inculcate "One, International and Authentic" vocation into our general membership?

Area 1: Ask the general membership to review the Statutes and comment on them. Father Bonaventure stated that some statutes may be deleted, some added, and some edited. With regard to the Formation Guidelines, the Provincial Council is considering assembling a group of present and former Formation Directors to study and make recommendations over the next three years. Province thinks that we need to simplify them and make them more flexible.

Area 2: As a result of the problems encountered in this year's nominations, the Provincial Council is considering two changes: the term in office is reduced from 6 to 3 years effective immediately (with the possibility of a second 3-year term), and the Provincial Councilors will be appointed by Father Provincial's Delegate, as was the case for the first Provincial Council. There will also be a change in the Visitation process, which will lighten the load on all participants. Effective immediately, there will be a Pastoral Visit every 6 years, and a Familial Visit at the 3-year interval between Pastoral Visits, following the model of the Friars. Visitators will be trained to look for potential Provincial Councilors when they are with Communities and Study Groups, and make recommendation to the Provincial's Delegate accordingly.

Area 3: Fr. Luis, our Provincial, is concerned that we understand our Vocation is not individual, but Carmelite, which means being part of the worldwide Community. It depends on a personal relationship with God expressed through the Carmelite Community experience and the living out of the Beatitudes.

By doing this, we hope that our priests will remember to refer anyone with our spirituality to our study group.

4. St. Francis Food Table for the Poor

International Teresian Meeting in Avila, August 2015

Dear Members of the Secular Order of Carmel,

Teresa of Jesus, the foundress of the Discalced Carmelite Order, was born in 1515. This means that in 2015, the Order of Carmel will be celebrating the 5th Centenary of the birth of the person whom we call "Our Holy Mother." There are many events that have been scheduled for next year.

I am writing to inform you of an international event called an "International Teresian Meeting" that is being organized to take place in Avila, Spain from the 10th through the 14th of August 2015. The purpose behind the gathering is that all the participants may grow in their understanding of the spirituality of St. Teresa while experiencing a spirit of "brotherhood, freedom simplicity and humility." It is also hoped that the participants will adopt a sprit of missionary availability and become ready to answer the question, "What do you want from me?" There will be time for study, reflection and prayer. There will also be an opportunity to visit some of the principal places associated with Teresa's life and ministry to the Church.

It has been suggested that up to 2,000 people may take part in this International Meeting. The event is open to all but in a special way Carmelite Seculars are invited to take part. I have been chosen by our Province to act as a coordinator to help organize participation on behalf of our Province. Pre-registration is to take place by the 31st of this month. Each person who pre-registers is expected to pay a registration fee of 25 euros, which translates to \$32.52.

The exact fee for participation in the meeting itself has not been specified, but it has been estimated that it will cost between 210 to 335 euros. Details regarding fees will be forthcoming. For now, we must think about organizing for participation. So, I would ask you to canvas your members so that we can get a good head count from your various groups, specifying names and providing contact information for each person who plans to attend. Later I will ask for the proper fees to be submitted.

The following information comes to us from the Secretariat for the Centenary of St. Teresa of Jesus.

Accommodations

Accommodation will be in retreat houses, residences and hotels. Four types of accommodation with different prices depending on the type selected will be offered. There will be also opportunity for registration without accommodation, to cover participation in the activities of the meeting and the common meal.

Conscious of the common heritage and spirituality that we share, and as you may already know, our two Orders, O.Carm. and O.C.D., have been developing different joint projects over the past two decades, we would like to invite your participation in the work of conservation on Mount Carmel.

During our meeting in Rome last June, both the General Council of the Order of Carmelites and the Definitory General of the Discalced Carmelites decided to initiate fund raising in their respective communities in order to support the restoration and conservation of the ruins of the first Carmelite monastery at the Wadi es-Siah on Mount Carmel, Israel. As part of the celebrations for the 8th centenary of St. Albert of Jerusalem, our Lawgiver; His Beatitude Fouad Twal, Patriarch of Jerusalem, will preside at the Eucharist on the 12th of October next here in Rome together with Fr. Fernando Millán Romeral, O.Carm., Prior General, and Fr. Saverio Canistrà, O.C.D., Superior General.

We would like to invite all our parishes, shrines, spiritual centres, monasteries, convents, schools, as well as other institutions and houses associated with us, to join in this important celebration by organizing a collection for this restoration on that same Sunday, i.e., on the 12th of October 2014.

We would hope that this might also be an opportunity for us to appreciate our origins and strengthen the bonds that unite all the members of the great Carmelite family around the world.

pretty piece of cream-colored gabardine cloth. She had already measured out an "example" pall, borrowed from St. Joseph's Abbey nearby, in order to determine the right dimensions and so the amount of fabric she would need.

Meanwhile, our Carmelite Sisters here at the Covington Carmel contributed to this labor of love. The Sisters had been given an embroidered Carmelite Coat of Arms. It was a donation to them from the family of George Gowey, Jr. The Sisters recognized that this embroidered piece of art would be the perfect centerpiece for the pall. Rosalie then hand stitched it in perfect position, attaching it to the pall with a lovely piece of gold trim that royally framed the piece.

As Rosalie was creating the pall, a dear member of our community was growing more and more ill—Betty Ketchum, who mused that she might be the first to have to use it. In addition to being sisters in Carmel, Betty and Rosalie were good friends. Betty's intuition proved correct. The pall was first used during her rosary and funeral services. In fact, it was during these two services for Betty that the pall was officially blessed.
